

Town of Grant Monthly Board Meeting
Grant Town Hall – 7:00 p.m.
August 1, 2022

The monthly meeting of the Grant Town Board was held at 7:00 p.m. on Monday, August 1, 2022 at the Grant Town Hall. Roll Call: Richard Britzke, Dale Klitz, Bill Bowers, Rick Grunewald, and Sarah Knaup. Four residents and two guests were in attendance.

Chairman Britzke read the agenda which was published in *The Marion Advertiser* on July 27, 2022. A motion was made by Bowers/Klitz to approve the agenda. Motion carried.

A motion was made by Klitz/Britzke to approve the minutes of the July town board meeting. Motion carried.

Public Comment Period: Ken Huebner asked if the town has an ordinance for cats. The town does not have an ordinance for cats. There are several residents on Uecker Street that are very upset about the large number of cats that a resident has. The resident lets the cats roam freely. A motion was made by Britzke/Bowers to send the resident a letter explaining the issue. Motion carried.

County Supervisor Update: Arlyn Tober stated that the county applied for a grant from the state, to upgrade dispatching equipment. The county also approved a new veteran's service officer, and installed a new air conditioning unit in the courthouse. Jerry Erdmann stated that the county is looking at placing items on a schedule to show when the items were purchased, the price, etc. The schedule will make it easier to budget in replacement costs of items. Erdmann also stated that bids will open Thursday for the remodeling of the dispatch office.

Approve Amos Yoder/Keith Krueger CSM: A motion was made by Bowers/Britzke to approve the Certified Survey Map for Amos Yoder and Keith Krueger. Motion carried.

Approve Aschenbrenner CSM: No action taken. CSM was not provided by surveyor.

September Town Board Meeting: A motion was made by Britzke/Bowers to hold the next regular town board meeting on Monday, September 12, 2022 at 7:00 p.m. due to the Labor Day holiday. Motion carried.

Plan Commission & Zoning – Wuske Event Barn Conditional Use Permit: The next Plan Commission meeting will be September 12th at 3:00 pm., if needed. No paperwork was submitted for the Wuske Event Barn Conditional Use Permit.

Approve Liquor, Beer, & Operator's Licenses for Wuske Event Barn: A motion was made by Britzke/Klitz to deny the liquor, beer, and operator's licenses for Wuske Event Barn. Motion carried.

Roads and Roads Maintenance: Crack filling will begin shortly.

Town Hall Reservations & Maintenance: A motion was made by Britzke/Klitz to approve town hall reservations for Betty Laatsch June 17th and July 15th, 2023, and Shirley Pockat July 16th, 2023. Motion carried. The ground has been marked for the new playground equipment.
