The monthly meeting of the Grant Town Board was held on Monday, April 3, 2023 at 7:00 p.m. at the Grant Town Hall. Roll Call: Richard Britzke, Dale Klitz, Bill Bowers, Sarah Knaup, and Rick Grunewald. Ten residents and seven guests were in attendance.
