Town of Grant Monthly Board Meeting Grant Town Hall – 7:00 p.m. June 5, 2023

The monthly meeting of the Grant Town Board was held at 7:00 p.m. on Monday, June 5, 2023 at the Grant Town Hall. Roll Call: Richard Britzke, Dale Klitz, Bill Bowers, Rick Grunewald, and Sarah Knaup. Two residents and two guests were in attendance.

Chairman Britzke read the agenda which was published in *The Marion Advertiser* on May 31st, 2023. A motion was made by Klitz/Bowers to approve the agenda. Motion carried.

A motion was made by Britzke/Klitz to approve the minutes of the May town board meeting. Motion carried.

<u>Public Comments</u>: Ken Huebner commented on a property across the street from the church. The property has a lot of rubbish on the lawn and it is very unpleasant to look at.

County Supervisor Update: Arlyn Tober stated that the Sheriff Deputies who live right on the county line would now be able to take their squad cars home, just like the deputies who live close to the Sherriff Department. He also stated that the county is working with New North Company, on getting a grant for broadband internet. Jerry Erdmann stated that the new horse arena at the fairgrounds is currently being built. He also stated that the county is looking at expanding or building a new justice center and courthouse. Discussion on this project has just started, so it would probably be at least 5 years before anything happens.

Roads & Roads Maintenance: Chip sealing and grass cutting will be done in June. The 2024 Bridge & Culvert Aid Project Application was discussed. A motion was made by Britzke/Bowers to approve the 2024 Bridge & Culvert Aid Project Application offered through the Shawano County Highway Department. Motion carried.

<u>Town Hall Reservations & Maintenance</u>: A motion was made by Klitz/Bowers to approve town hall reservations for Mary Jo Malueg July 22nd and Ron Polzin August 6th. Motion carried. The new playground equipment has been installed.
